### To receive your benefits:

  - One transaction of Bill Pay or direct deposit (ACH) within the 60 days of the account opening
- To qualify the special rate of CD account(s)

In order to receive the CD special rate described above, you must (1) open a CD account with non-interest checking or business checking account no later than 05/31/2024; (2) make an initial deposit to CD account of at least \$10,000 ; and (3) additional deposit of at least \$1,000 into the newly opened non-interest checking or business checking account at the same time; and (4) the eligible checking account must be set up with at least one transaction of a direct deposit/ Automated Clearing House (ACH) of at least \$250 or bill pay with any amount within the first 60 days the account is opened. If the account has no direct deposit/ACH/ Bill pay made within 60 days of the account opening, the CD rate will be adjusted 0.50% lower than the disclosed rate no other CD terms will be changed. Gateway has discretion over any final decisions.

Annual Percentage Yield effective as of 03/20/2024. The minimum balance to earn APY and the minimum deposit balance is \$10,000. Fees could reduce the earnings on the account. An early withdrawal penalty will apply. Subject to terms and conditions .
